IN EACH CASE, CASAS STRIVE TO QUICKLY SECURE A SAFE, PERMANENT HOME BY GATHERING INFORMATION FROM PARENTS, RELATIVES, TEACHERS, NEIGHBORS AND FOSTER CARE PROVIDERS, AND WORKING CLOSELY WITH COMMUNITY SERVICE PROVIDERS TO HELP CHILDREN AND THEIR FAMILIES GAIN ACCESS TO NEEDED SERVICES. KEY EMPLOYEES PARTICIPATE IN AN ANNUAL REVIEW OF THEIR PERFORMANCE COMPARED TO OBJECTIVES. THE E.D. DETERMINES THEIR NEW YEAR COMPENSATION, MERIT OR BONUS PAY BASED ON PERFORMANCE, WHERE THEY FALL IN THE SALARY BAND, AND HOW THEY COMPARE AGAINST LIKE SALARIES (RESEARCHED EVERY FEW YEARS).

IN THE CURRENT FISCAL YEAR UNDER AUDIT, THERE WAS A SALARY FREEZE IN PLACE FOR ALL EMPLOYEES DUE TO BUDGET CONSTRAINTS, SO THE ONLY INCREASES THAT WERE GIVEN CAME FROM PROMOTIONS TO NEW POSITIONS.
